GLOSSARY

詞彙

Associate means the spouse or any child of a client.

有聯繫者指客戶的配偶或任何子女。

Custodian means: –

- (1) A corporation the principal business of which is to act as a custodian of securities or other property for another person, whether on trust or by contract; or
- (2) Any of the following persons whose business includes acting as a custodian of securities or other property for another person, whether on trust or by contract:
 - (i) An authorized financial institution;
 - (ii) A bank which is not an authorized financial institution, but is regulated under the law of any place outside Hong Kong;
 - (iii) A licensed corporation;
 - (iv) A person carrying on the business of the provision of investment services and regulated under the law of any place outside Hong Kong,

保管人指–

- (1) 主要業務是作為另一人的證券或其他財產的保管人 (不論是以信託或合約形式保管) 的法團；或
- (2) 業務包括作為另一人的證券或其他財產的保管人 (不論是以信託或合約形式保管) 的下述人士：
